

## THE PREZ SEZ

The record-setting drought we're experiencing this winter served as a dramatic backdrop to our February 8 meeting. This program, Valuing Our Watersheds, focused on understanding how we get water, the lynchpin that underlies California's economy. The drought has reminded us that, except for air, it's hard to think of anything that impacts the quality of one's daily life more than water.

Ironically, rain poured down in torrents on the day of the meeting, but that didn't prevent members of the local community from attending the meeting.

But why is the League, a nonpartisan political organization, interested in water? We adopt and advocate on public policy issues of local, state and national significance that our members have studied. One of our positions, Defending the Environment, includes protecting water quality. Our speakers addressed this issue from several perspectives.

Rem Scherzinger, General Manager of the Nevada Irrigation District, provided us with a wealth of information about the many watersheds comprising our 70,000 acre watershed, which provides water for local consumers and many beyond our region. He emphasized that while much of the snowpack originates at the granitic alpine level in the mountains, the forests below perform a vital role in controlling run-off and filtering the water.

Caleb Dardick, Executive Director of the South Yuba River Citizens League, inspired us with how local citizens are working to protect, not only the river, but the many resources associated with it, for instance, forests and salmon. He reinforced the connection between water and these resources that are mutually dependent. The South Yuba River drains a huge watershed, but the dams built on it can obstruct its functioning. SYRCL members fought for 16 years before the Yuba was finally designated as a "Wild and Scenic" river for 39 miles of its length, protecting it for future generations.

Izzy Martin, Chief Executive Officer of the Sierra Fund, explained that the Fund works to increase and organize investment in the Sierra Nevada region's natural resources and communities, with an emphasis on collaboration with other agencies and NGO's (non-governmental organizations). She focused on the toxic residue from old gold mining operations where mercury from the coastal mountains was brought in to separate the ore from the sludge. When mining became no longer economically viable, the toxic mercury remained in the old mines and in our waterways. But there are contemporary threats also, including unregulated marijuana grown in the forests where water and power are illegally diverted, and toxic waste is left behind when these unregulated crops are abandoned.

Our February program epitomized what the League of Women Voters is all about. We are a grassroots political organization, and our members tell us that they want programs about issues that affect their lives, like water and the ongoing threat of drought. We strive to inform voters not only about local ballot box issues and candidates, but also to find the best speakers about issues like water and drought that affect all of us



### ***League of Women Voters of California News - February 11, 2014***

#### **We Charge the State with Illegally Denying 60,000 the Right to Vote**

We joined the ACLU of California and the Lawyers' Committee for Civil Rights of the San Francisco Bay Area in a lawsuit charging the state with unconstitutionally stripping tens of thousands of people of their right to vote, disproportionately impacting people of color.

We believe the Secretary of State's Office violated state law by issuing a directive to local elections officials asserting that people are ineligible to vote if they are on post-release community supervision or mandatory supervision. These are two new and innovative forms of community-based supervision created under California's Criminal Justice Realignment Act for people recently incarcerated for low-level, non-violent, non-serious crimes.



**VOTER SERVICE COMMITTEE UPDATE:**

Voter Service has scheduled four Candidate Forums for the June 3, 2014, Primary Election:

Thursday, March 20:	State Assembly, District 1 House of Representatives, District 1
Thursday, March 27:	Board of Supervisors, Districts 3 and 4
Thursday, April 3:	Superior Court Judge
Thursday, April 10:	District Attorney

All forums will be held at the Board of Supervisors Chambers, Rood Center, 950 Maidu Avenue, Nevada City, from 7 pm to 9 pm.

Declaration of Intention of Candidacy for Superior Court Judges ended February 5.

Declaration of Candidacy filing period for all local, nonpartisan offices is February 10 to March 7 with an additional extension period for candidates other than the incumbent if the incumbent does not file.

The State Assembly and the U.S. House of Representatives are the only partisan offices on our Forum schedule. The Libertarian Party of California has this statement on their website: *“Proposition 14 passed by California voters in 2010 has curtailed Libertarian candidate races for Congressional or State level partisan offices. A lawsuit is pending on this issue.”* (NOTE: Proposition 14 created a “Top Two” or “Open Primary” election system except for U.S. President and Central Committee offices.)

John Lewis, a U.S. Representative from Georgia stated: *“In a democracy such as ours, the right to vote is precious. It is almost sacred. It is the most powerful non-violent tool the people have in a democratic society.”*
